

FAN EXPERIENCE PROGRAM PARTICIPANT GENERAL RELEASE FORM

For good and valuable consideration, receipt of which is hereby acknowledged, I, on behalf of myself and/or any child/ward ("Child") who may participate in one or more Programs (as defined below), hereby release and hold harmless Golden State Warriors, LLC, GSW Arena LLC, the National Basketball Association and its Member Teams, NBA Properties, Inc. and their respective parents, subsidiaries, affiliates, directors, officers, governors, employees and agents (the "NBA Parties") and their respective licensees, sponsors, and designees from and against any and all claims, causes of action, or demands relating to or arising out of, as applicable, my/my Child's performance for the Golden State Warriors and/or my/my Child's admission to and voluntary performance in one or more Fan Experience programs, which may include, but are not limited to, Play Where the Pros Play, Primetime Youth Basketball or Performance, Halftime Youth Basketball or Performance, National Anthem, Pre-Game Shoot Around, Fan Tunnels, Anthem Buddies, Birthday Packages, and/or Post-Game Free Throws (the "Program").

I acknowledge that the risk of illness (including, without limitation, any virus), or injury from the activities involved in the Program is significant, including the potential for permanent disability and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious illness (including, without limitation, any virus), and injury does exist. I, FOR MYSELF AND ON BEHALF OF MY CHILD (AS APPLICABLE) AND OUR HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN, KNOWINGLY AND EXPRESSLY ASSUME SUCH RISKS, both known and unknown, HOWSOEVER CAUSED OR ARISING AND WHETHER BY NEGLIGENCE OF THE INDEMNIFIED PARTIES OR OTHERWISE, and accept personal responsibility for the damages following such illness (including, without limitation, any virus), injury, permanent disability or death.

By signing this General Release Form, I expressly waive any and all rights I and/or my Child may have under California Civil Code Section 1542 (or any other statute or rule of similar import, intent or effect), which states:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

I grant full permission to the NBA Parties (and their respective licensees, sponsors and designees), by any means, whether now known or hereinafter developed, to exhibit, record, reproduce, broadcast, transmit, publish, sell, distribute, perform, use and re-use, and to license others to exhibit, record, reproduce, broadcast, transmit, publish, sell, distribute, perform, use and re-use, for any purpose, in any manner, without further notification, authorization or compensation to me or anyone on my and/or my Child's behalf, my and/or my Child's name and likeness, and any photographs, videotapes, motion pictures, recordings, or other record of any Program (or any part or parts of my participation in any Program) in any and all media, whether now known or hereafter developed, worldwide and in perpetuity, and I represent and warrant that no further permission is required for the NBA Parties to use the Program as provided herein.

I further represent and warrant that: (i) I and/or my Child have the right to participate in the Program, (ii) the Program will not reflect badly on the NBA Parties, bring the NBA Parties into public disrepute, contempt or scandal, or otherwise offend the community, (iii) no part of the Program will attempt to be or make a statement that is political in nature or otherwise convey a political message, and (iv) I have full authority to execute this General Release (including on behalf of my Child) and do so with full knowledge of the facts and circumstances surrounding the Program and the rights that I am granting herein.

I, on a joint and several basis, agree to indemnify the NBA Parties for (i) any claims, damages or causes of action relating to or arising out of the Program and (ii) any breach of any representation or warranty contained herein.
